Information to be transferred from the archives of La Marina Sunlife S.L, Viviana Deckx Ceulemans, Camping Los Naranjos SL and Devesa Gardens SLU

As a general rule, La Marina Sunlife S.L., Viviana Deckx Ceulemans, Camping Los Naranjos SL, and Devesa Gardens SLU only share personal data with third parties, or grant them access to it, when necessary to provide the requested service properly, to comply with legal, tax, and corporate obligations, or to carry out certain subcontracted organizational processes or activities (Access to Data on Behalf of Third Parties). They provide certain services or collaborate in the development of certain activities, and may have access to the personal data we manage. In addition, we use certain subcontracted services to support the provision and development of our services. This is primarily the case with external hosting and web hosting services. The corresponding external data processing agreements have been signed for the provision of these services, ensuring compliance with regulatory requirements. Information retention period

As a general rule, at LaMarina Sunlife S.L., Camping Viviana Deckx Ceulemans, Camping Los Naranjos SL, and Devesa Gardens SLU, we only retain personal information and data for as long as necessary to fulfill the purpose for which the data was obtained, as well as to address any potential claims or liabilities arising from data processing. Generally, once the service has ended, the data is blocked, and no further processing is carried out beyond keeping it available to [the relevant parties].

Public authorities, judges, and courts may retain personal data to address any potential liabilities arising from the processing, for the duration of the applicable statute of limitations, after which the data must be deleted. Furthermore, to determine data retention periods, La Marina Sunlife S.L. considers local laws, contractual obligations, and the expectations and requirements of our clients. When we no longer need personal information, we securely delete or destroy it.

Applicable law and jurisdiction
